To do a complete replacement for a new ladder the cost would be \$22,987.00 for just the ladder. Installation over and above the ladder cost would be approximately \$5,000.00. The other option is to do a retrofit for \$19,250 which will get the ladder working again. The current ladder has an articulating handrail and they are proposing to fix the handrail so it does not move. There is also some wear and tear as they used steel bolts with aluminum. This does not work so the bolts need to be replaced. There would also be a repair to the cylinder. The complete cost \$19,250.00. Could take up to $6 - 8$ weeks to fix.
