- 10 Year Capital Funding

Be it further resolved that the **Town of Sexsmith** commits **\$12,400** (20% of the total project cost) **from** its 2018 budget toward the costs of this initiative. The total project cost is \$ 62,000. It is our understanding that the contribution from Municipal Asset Management Program will be \$49,600 which is 80% of the total project cost.
