Envirothon is an international environmental competition where students are expected to study 6 areas of Ecology and apply their knowledge during the competition. The competition is composed of field tests, where the kids are tested in the areas of Forestry, Aquatic Ecology, Wildlife, Soil and Land Use, Recreational Impacts, and a Current Issue. It also has an oral presentation where the kids apply their knowledge again to solve a current issue.

Sexsmith Secondary School Envirothon Team consists of five members and an alternate competitor. The core team started with Nicholas Kosa, Anakate Dueck, Ashley Ikenouye, Derek Dodd, and Jordan Rycroft. For the international competition, Xaverie MacLennan stepped in for Ashley, who could not make it to California. Austin Fedchuk also accompanied the team to California to serve as an alternate competitor should the case arise.

The team placed 26th out of 54 teams and achieved 4th in Canada. The team had to win regionally and provincially to qualify for the competition. They are already starting to prepare for next year's competition. Alberta is fairly new to environmental studies. Pennsylvania has over 60 teams. Studies are generalized. This year, ground water was the focus of the competition.
