PUBLIC SESSION

Mr. Jantz spoke about Plan B and passed out a newspaper clipping about the Mayor of Saskatoon and their Property Tax Fairness, a handout he gave to Council. There was discussion at Chamber of Commerce. Plan A was that the Chamber of Commerce would present the Saskatoon proposal. He will also bring it to the Sustainability Committee for discussion. Taxes on commercial property in Sexsmith went up significantly – very significantly for his business. "Small wonder businesses are not clamoring to set up in Sexsmith." In 2009, the Town would have needed a 5% decrease in commercial property tax for eight years to bring commercial property tax to the rate of residential property. It would make Sexsmith more attractive to business. It has been said in Council for many years that commercial assessment has to carry the heavy end of the stick. Please keep the Saskatoon proposal in mind when passing the budget.

Councillor Skjaveland: Is this the only municipality that you found that tried to lower the taxes?

Mr. Jantz: No, I took this out of the Canadian Business Magazine. There are many communities in our area that are closer to equal than we were in 2009.

Councillor Skjaveland: As you know, the commercial assessment was way under where it should have been for the past 4 - 5 years, so that was one of the reasons for the increase.

Mr. Jantz: That is why I say that for the 2010 assessment there were some inequities. But in order for our Town to be attractive to business, the commercial assessment has to be down to a much fairer ratio. Grimshaw is.

Mayor Lagace: Dennis brought this to me a while ago. It is booming in Saskatoon and people could not afford to live there.

Councillor Siggelkow: When we are looking at 2.7 to 1.75, is that their mill rate?

Mr. Jantz: No. It is the ratio.

Councillor Skjaveland: My daughter in Saskatoon did not get a break. Residential taxes are going up.
