- 2. Things that could help these concerns are more RCMP presence in Town, more visits by drug dogs in the schools, and changes to the Young Offenders' Act.
- 3. To assist in the prevention, enforcement or reduction of crime, the Town of Sexsmith promotes a very active COPS program.
- 4. To address crime and safety concerns, we promote the COPS program, have a reward for the report of incidents that lead to criminal conviction, have put up cameras for surveillance and have met with business owners to give them tips for crime prevention. We are looking at installing a WASP or MOSQUITO sound deterrent.
