> Jeanne questioned whether the current infrastructure could keep up with the sewer from residents' homes. She asked how a 10 foot blockage in the sewer pipe could have happened. The CAO said she spoke with Aquatera. They said there have not been major problems with the line and to keep receipts for any damage that may have occurred. The CAO asked if the backflow protection was working. Jeanne said yes it was checked and was working. The CAO said Aquatera will come out and camera the lines. At this time they have no explanation as to why the backup happened. Mayor Lagace said Aquatera will camera the lines tomorrow to see if the line has collapsed somewhere. Councillor Cooke asked if someone from the Town could be present when they camera the lines. Merry said if the flow comes in fast and hard the backflow valve cannot do its job. Councillor Barnfield asked Jeanne how they could tell her what was in the line if they have not sent the camera in yet? Jeanne said this is what they told us. I am frustrated I am not able to use my basement. She asked if she could give the Town the land that is across the creek from her. The CAO said this would be a Council decision. Mayor Lagace asked that Jeanne please send a letter to the Town with her intentions. Merry asked if the Town would approach Aquatera and ask them to replace the lines. She said maybe the pipes are old and maybe the pipes can't take what is coming in from all around us. Jeanne asked if it

Mayor Lagace told Jeanne someone will be contacting to meet with you and that he will meet with Aquatera Thursday.

Dan Dibbelt- Executive Director, Peace Region Economic Development Alliance

Dan made a presentation on behalf of PREDA. These are some of the highlights:

- -PREDA is one of 12 alliances in Alberta these groups were formed around 1998.
- -2003-2004 it was decided the alliance was too large some left and formed another alliance.
- -Some alliances shut down because funding has been dropped by the Provincial Government.
- -PREDA is currently working towards being self sustaining.
- -They are focused on rural areas.
- -They do regional research and have program funding.
- -There has been a new focus on aboriginal engagement.
- -The Town can gain access for a cost to the metasoftware to help look for grants.
