Arlen also stated that the Church has discussed building on that site. The Church would like to have the Town clear the rink after a big snow because it is more than a snow blower and one person can handle.		
	Brian Molendyk was present to discuss the proposed senior/adult housing development. Proposed plans for the new building were reviewed. It would be a gated community and there would be enough space for 3-5 unit complexes. Some drainage would be required because it is in a low area. Brian stated 75% would be sold and the remainder could be rented. He stated the units would probably sell for about \$275,000.00.
