Glen Olson from Active Security made a proposal to Council regarding security patrol services in Sexsmith between the hours of 11:00 p.m.-6:00 a.m. Several scenarios were presented to Council regarding possible service options. Glen felt that the extra security would reduce crime. Active Security can be a first responder for fire calls, medical calls and can respond to burglar alarms as well. The security company can address residents who have intruders in their yards. According to Glen, Rural RCMP are not available after 3:00 a.m. He explained the company would have a five minute response time to anywhere in town. The cost would be approximately \$35.00/hour. The company would be willing to enter into a short term agreement and re-assess this after 6 months.
