DELEGATIONS Jennifer McLaughlin, Sexsmith Wellness Coalition

The Sexsmith Wellness Coalition was successful in securing a \$10,000 grant from Thrive on Wellness an Alberta initiative. The coalition plans to start a walk/run club. It is planned to start March 10, 2013. Thrive on Wellness has encouraged the coalition to look for ways outside of a fitness facility to promote wellness in the community. A walk/run race is being planned for May 5th. The Sustainability Plan of the Town of Sexsmith looks to promote fitness. If the Town were to partner with the coalition there could be someone involved parttime in going after grants. The coalition is looking to do a scavenger hunt for Easter. Councillor Siggelkow asked what kind of fees they are looking to charge. Jennifer said \$25 per year for the walk/run club. The leaders would be volunteers. There would be an education component to the walk/run club. Jennifer is a certified fitness instructor for groups. This would be a pilot project only. The coalition is only looking at a one year commitment from the Town to partner funds. Councillor Jickling wondered if the co-coordinator would be available to help groups involved in fitness such as the Ag Society. Jennifer said that yes they could be available to groups.
